RWHAP Part B and the State of Louisiana Federally Facilitated Marketplace (FFM)



- Population 4.4 million
- Uninsured residents (2013)
 - 21.7% of adults
 - 3.5% of children
- State declined PPACA Medicaid expansion
- Elected FFM
- Ryan White funding:
 - 2 Part A EMAs
 - 8 Part C clinics
 - Part B/ADAP-funded health insurance program
